

## GRANT/SCHOLARSHIP AGREEMENT

This grant/scholarship is awarded by The Delta Foundation subject to the following terms and conditions:

A. Grantee confirms that it is Delta Sigma Theta Sorority, Inc. (which includes its regions and chapters) or it is an organization that is currently recognized by the Internal Revenue Service (IRS) as a public charity under sections 501(c)(3) and 509(a)(1), (2), or (3) of the Internal Revenue Code (the "Code") and Grantee will inform The Delta Foundation immediately of any change in, or IRS proposed or actual revocation (whether or not appealed) of its tax status described above.

B. This grant may be used only for Grantee's charitable and educational activities. The purpose of this grant is \_\_\_\_\_. While the Delta Foundation understands that the Grantee may participate in the public policy process, consistent with its tax-exempt status, Grantee may not use any Delta Foundation grant funds to lobby or otherwise attempt to influence legislation or to influence the outcome of any public election. This grant must be used for the project(s) identified above, as described in the Grantee's proposal and related correspondence, and may not be expended for any other purposes without The Delta Foundation's prior written approval. Grantee accepts responsibility for complying with this agreement's terms and conditions and will exercise full control over the grant and the expenditure of grant funds. The Delta Foundation may request that Grantee return any grant unexpended grant funds remaining at the end of the project period.

C. Grantee will provide to The Delta Foundation an annual grant/scholarship report and audited financial statements and/or accounting of grant/scholarship funds at the end of Grantee's current fiscal year. Grantee will provide promptly other additional information, reports and documents as The Delta Foundation may request and will send to and allow The Delta Foundation and its representatives to have reasonable access during regular business hours to files, records, accounts or personnel that are associated with this grant, for the purpose of making such financial reviews, verifications or program evaluations as may be deemed necessary by The Delta Foundation.

D. Grantee will allow The Delta Foundation to review and approve the text of any proposed publicity concerning this grant prior to its release. If this grant is to be used for a film, video, book, or other such product, The Delta Foundation reserves the right to request a screening or preview of the product, during the final production stages, before deciding whether or not to be credited as a funder of the product.

E. The Delta Foundation reserves the right to terminate this agreement or discontinue, modify or withhold any payments to be made under this grant award or to require a total or partial refund of any grant funds, if it, in The Delta Foundation's sole discretion, such action is necessary: (1) because Grantee has not fully complied with the terms and conditions of this grant; (2) to protect the purpose and objectives of the grant or any other charitable activities of The Delta Foundation; or (3) to comply with any law or regulation applicable to the Grantee, to The Delta Foundation, or this grant.

F. The requirement to report information to the Foundation regarding funds expended and programs conducted will survive the termination of this agreement. Reporting requirements may change as required to maintain our 501(c)(3) status. Grantee will be notified of such changes as soon as possible.

G. Grantee's deposit, negotiation or endorsement of the enclosed check will constitute its agreement to the terms and conditions set forth above. However, for The Delta Foundation's files, please have the enclosed copy of this agreement reviewed and signed where indicated by an authorized officer of Grantee and then returned to us within three weeks of receipt of this agreement. Grantee may wish to have this agreement reviewed by legal counsel.

H. If applicable see Attachment A for other specific grant/scholarship restrictions or reporting requirements which may apply. Attachment A is incorporated hereto.

On behalf of Grantee, I understand and agree to the foregoing terms and conditions of The Delta Foundation's grant, and hereby certify my authority to execute this agreement on Grantee's behalf.
